◆ BULL RUN ◆ MEMBERSHIP

Membership Fees: Membership fees are due in full upon confirmation of member or in accordance with the established quarterly payment plan schedule due the first week of every applicable quarter. ***Payment plan will have a processing fee of \$200 for Quarterly.***

Member Conduct: The membership of any person hereunder may be revoked or canceled at any time by management for inappropriate, rude, illegal or immoral conduct. In the event of cancellation, the affected member shall receive a pro-rated refund of membership dues and be asked to leave the club. Range Balls cannot be shared. Any person who shares range balls will lose privileges without a refund.

Membership: The membership of any person under this agreement is for a term of one year, and commences on the date of confirmation of membership. The membership of any person under this agreement shall not be construed to grant such member any equity or legal ownership in Bull Run Golf Club or club's facilities. Membership may be removed from annual membership at the sole discretion of the management. ***Members who wish NOT to renew their membership must submit a notice in writing 60 days in advance.***

Reservation Policy: Members can make a reservation two weeks in advance. Members must cancel reservations 24 hours in advance. ***Failure to cancel a reservation is a violation of membership privileges. The first violation will result in a verbal warning. A second violation will result in a charge to the member's credit card.*** Inclement weather is not a violation of policy.

Cancellation: Bull Run Golf Club reserves the right to terminate this program at any time by giving notice in writing to all members 120 days prior to termination of the program. The annual fee would be pro-rated for the remaining months of each membership.
